Civil Service Commission: The City of SeaTac has an immediate vacancy for a Civil Service Commissioner. Comments Requested on Stormwater Management Program: City staff have recently published an update of the City's Stormwater Management Program (SWMP) and are looking for public input on this developing program. The SWMP and an annual report, which are required under the National Pollutant Discharge Elimination System (NPDES) permit, describe the City's comprehensive approach to stormwater and water quality issues.

Like large industrial sites and development projects, the City of SeaTac is subject to federal regulation under the Clean Water Act. In the case of cities with populations of less than 100,000, we are specifically subject to the Western Washington Municipal Stormwater (NPDES) Phase II Permit which regulates stormwater with the intent of improving water quality by reducing pollution carried by stormwater. The permit requires cities to develop or modify their stormwater management programs to meet the conditions of the permit. These programs include public involvement and education, illicit discharge investigation, development review, and inspection and maintenance of stormwater facilities. While the NPDES Permit went into effect in February of 2007, its requirements are phased through 2012.

The latest update to the SWMP and Annual Report are now available on the City's Surface Water Management website at http://www.ci.seatac.wa.us/services/stormwater.htm, or at the City Hall Permit Counter. This update highlights program accomplishments from 2010 and describes ongoing programs. These 2010 accomplishments include completion of public stormwater system mapping, implementing new codes, policies and procedures for construction site run-off and stormwater maintenance programs, and the creation of a new water quality program – the Illicit Discharge Detection and Elimination Program.

Later this summer our resident little league, SHALL (South Highline American Little League), will host the state softball tournament at Valley Ridge Park. Tournament action will begin on Saturday, July 16 and will wrap up the following Saturday, July 23. This will be the third consecutive year that SHALL has hosted a state level event which brings people into SeaTac from all across the state.




