The City has an existing Managed purchase agreement with Trebron Company for the City's anti-virus, anti-spam, Detection and email gateway protection solutions. In the 2023-2024 Biennial Budget, the Council approved a decision card to add a Network Monitoring and Response and Solution to the City's network security infrastructure. X Recommendation for Council Approval as an Action Item 6. Travel Policy Gwen Pilo, Finance & Systems Director, presented a proposal to amend the travel policies, regulations, and procedures. This policy aims to provide a comprehensive travel policy that is easy to read and follow so users can gain compliance with the least amount of stress. Director Pilo reviewed the substantive changes to the policy. Council Member Kwon requested a trip report summary requirement for staff and council. If all requests are approved, the ending fund balance across all funds is estimated to be \$125.5 Million at the end of 2024.
