I have seen stolen cars on the property. I have watched swat team of some sort have to come in a forcefully remove a young child from living in a non working, dilapidated RV in 90 degree weather. I have watched people on the property shoot up drugs. I have seen the influx of comings and goings only to assume they are dealing drugs on the property. I have seen the number of items, trash grow on the property causing it to look like a hoarder house. I have had to deal with one of them flying a drown over my property. I have had to deal with them burning things that aren't just charcoal and wood to the point where I can smell it inside my house. I have had to deal with protecting my children from lose dogs on the property. When will enough be enough. I know the city is aware of the rap sheet a mile long for this property it is your job to end this nonsense.

I want to raise my family in a neighborhood where I feel safe to walk my kids, where I feel safe to have my kids play in their own back yard, where I feel I will not have to worry about them being exposed to gun violence and drug use at such a young age. The city of SeaTac and you council members need to do right by your community members and put a stop to this property.
