Subject: Planning the City Together: A Briefing on SeaTac's Major Planning Projects

Summary

Since the Spring of 2022, the City has invested significant resources in updating its long-term growth and development policies by funding the following projects:

- Envision SeaTac 2044: Major Comprehensive Plan Update Project
- Transportation Master Plan (TMP) Update Project
- City Center/Airport District Subarea Plan Project

The purpose of the upcoming briefing is to provide a status update of these three projects. This memo includes background information on the projects and highlights issues that will be further discussed at the project briefing.

Project Status Update

NEW "BRANDING" TO CONNECT THREE PROJECTS

- Proposed "Planning the City Together" Initiative: Because the Transportation Master Plan (TMP) and City Center/Airport District Subarea Plan (once adopted) are part of the Comprehensive Plan, staff is proposing an overall "brand" or name that is intended to emphasize the connection between the three projects.
- "Planning the City Together" Roll Out: The name "Planning the City Together" will be announced to the public the week of August 14th through a blog article and web page that will link to information about the three projects.

ENVISION SEATAC 2044: MAJOR COMPREHENSIVE PLAN UPDATE PROJECT

- Main Project Goals: To update SeaTac's Comprehensive Plan and re-set its growth and
 development strategies for the years 2024-2044, including updates that incorporate City priorities
 and align with new state and regional growth requirements. The project will closely coordinate with
 and leverage work from the Transportation Master Plan (TMP) update and City Center/Airport
 District Subarea Plan projects. The project will also facilitate a robust, inclusive community
 engagement process for both the Envision 2044 Comprehensive Plan and Transportation Master
 Plan (TMP) update projects.
- City Council Contract Authorization: 4/11/2023
- Tasks Completed:
 - Early Work: To meet the goals of the Department of Commerce GMA Periodic Update Grant, the consultant team completed an audit of all policies in the Comprehensive Plan and their compliance with new state law or regional planning requirements enacted since the last major Comprehensive Plan update in 2015. A draft public involvement plan was also created that will be presented at a future meeting.

- Tasks Underway:
 - Preparation for Public Project Kick-Off: Staff is working on materials for the project website which will be announced the week of August 14th as part of the rollout for the "Planning The City Together" initiative.
 - Preparation for Kick-Off of Citywide Vision Update Public Involvement Process: Staff is
 also developing materials and community engagement activities for citywide public
 involvement in updating the City's growth and development vision.
 - Current City Vision Statement & Proposed Approach to Vision Update:

EXISTING VISION STATEMENT (Ch. 1 Introduction & Framework Element

The City of SeaTac is envisioned to be economically strong, environmentally sensitive, visually pleasing, and people-oriented with a socially diverse but cohesive population and employment mix. These attributes create a positive identity and image for the community and contribute to a city of the future that works.

The essence of a growing, prosperous, and vibrant City of SeaTac is found not in its built or natural environment alone but in the collective spirit of those who live and who work within the SeaTac community.

The built aspects of this community—its residential and commercial structures, transportation network, park and recreation facilities, utility systems and other public and private facilities, as well as the natural environmental setting—are not considered as ends in themselves, but as means for enhancing the quality of life and enriching the human spirit.

PROPOSED CHANGES FOR PUBLIC CONSIDERATION & INPUT

- Add specificity to current vision's "value statements" to clarify where and how the city will grow.
- Other priority issues raised as priorities from SeaTac community members during Citywide Vision Update public involvement process.

TRANSPORTATION MASTER PLAN (TMP) UPDATE PROJECT

- Main Project Goals: Update the Transportation Element and Transportation Master Plan (TMP) in close coordination with Envision SeaTac 2044 Major Comprehensive Plan Update Project. Project tasks include:
 - Inventory of existing conditions and incorporation of information and City priorities since last TMP update in 2015.
 - o Update plans for all modes (pedestrian, bicycle, vehicular/roadway, freight.
 - Identify capital projects and programs.
 - Update Travel Demand Model (TDM) in partnership with Port of Seattle.

- City Council Contract Authorization: 4/11/2023
- Tasks Underway

 Port of Seattle team members, and Major Comprehensive Plan update project staff.
 - Kick-Off Travel Demand Model (TDM): Project team is starting technical work on travel demand model.

CITY CENTER/AIRPORT DISTRICT SUBAREA PLAN PROJECT


- Main Project Goals: To complete a subarea plan and code update that implement the vision established in Phase 1 of the project: to create a "walkable urban district."
- City Council Contract Authorization: 5/24/2022
- Tasks Completed:
 - Data Gathering/Technical Work: Project staff has collected significant background and demographic data and completed a draft market study and existing conditions report on transportation conditions in the district.
 - o **Community Engagement**: The following activities have been completed.
 - Activity 1: Big Ideas Poll (online).
 - Activity 2: Community Design Workshops (July 18-20). Detailed information on the workshops will be presented at the upcoming briefing.

Tasks Underway:

- **Technical Work:** Project staff is working to complete existing conditions and infrastructure assessments and the market study.
- Community Engagement: Staff is preparing for targeted engagement activities that will
 facilitate input from hard-to-reach communities such as families with children, apartment
 residents, and members of the district's BIPOC communities. Project staff will also be
 undertaking additional business outreach.
- Refinement of District Vision & Development Concept: Staff will utilize information from data gathering, technical work, and community input to propose refinements to district's vision and development concept. Once this work is completed, it will be brought out to the public for community review.






TRAVEL DEMAND MODEL

- Will be localized version of PSRC Soundcast Activity-Based travel demand model
 - ABMs model daily travel patterns of a synthetic population using all modes
 - Will be sensitive to active transportation infrastructure/connectivity
 - Can identify/track beneficiaries for equity analysis
 - Captures traveler timing responses (peak spreading)
- Bi-weekly model coordination meetings initiated (Port, City, consultant team)







Subject: Community & Economic Development: Update

Summary

The purpose of this memo and presentation to the PED committee is to provide an overview of the Community and Economic Development (CED) department work plan and approximate schedule. The work plan summarized here does not include items that do not normally require City Council oversight (e.g., building permit review and inspection).

CED work plan and approximate schedule

Goals and policies.

The subarea plan and the Comprehensive Plan are documents that articulate the community's aspirational goals. These documents also contain policies that describe aspects of the goals and the strategic approach that SeaTac will use to achieve its goals.

- 1. City Center / Airport District subarea plan.
 - o *Summary:* This subarea plan update will establish updated goals and policies for the City Center / Airport District and will be accompanied by amendments to the City's development regulations. The City will also conduct a parking study as part of this work, to inform parking regulations within the urban center.
 - o *Schedule:* The subarea plan is on track for completion by the end of 2023. Adoption of amendments to the development regulations may occur in 2024.
- 2. Comprehensive Plan 2044.
 - o Summary: This major update to the SeaTac Comprehensive Plan will establish goals and policies for the entire City and ensure compliance with the Growth Management Act. The update will also incorporate changes prompted by recent legislation adopted by Washington State. The Comprehensive Plan 2044 update will be accompanied by amendments to the City's development regulations. (CRF23-05)
 - o *Schedule:* The Comprehensive Plan update is on track for completion by the end of 2024. Some amendments to the development regulations may occur in the first half of 2025.

Strategic plans.

The strategic plans are an expansion of the implementation strategies described in the subarea plans and the Comprehensive Plan. These documents describe the specific actions that SeaTac will use to implement its aspirational goals. Specific actions may include funding of projects, creation of new programs and/or refinement of existing programs, or adoption of new ordinances.

- 3. Tourism Destination Development Plan (TDDP).
 - o Summary: The TDDP will guide the City's investment of lodging tax monies into the SeaTac community.
 - o Schedule: City Council review and adoption of the TDDP is scheduled for October of 2023.
- 4. Human Services Strategic Plan.
 - o *Summary:* Funding for this plan will be part of a budget amendment in Q3 of 2023. If approved, the Human Services Strategic Plan will update the community needs analysis and

establish an overall strategy for providing human services to the SeaTac community, including community member focused workforce development analysis. (CRF23-04, CRF22-15)

o *Schedule:* If funded, consultant selection is scheduled for late 2023. Completion of the plan is anticipated in 2024. P&R committee review and policy guidance expected in Q1 2024.

Development regulations.

Amendments to development regulations, sometimes referred to as "code amendments", result in changes to the City's regulations on private development. These amendments are intended to ensure that new private development is consistent with the SeaTac community's goals articulated in Comprehensive Plan or subarea plans.

- 5. City Center / Airport District subarea plan and Comprehensive Plan 2044 amendments. Note that amendments to development regulations are included in the project summaries above.
- 6. Multifamily Tax Exemption (MFTE).
 - Summary: The PED committee has directed the Planning Commission to review these regulations. Amendments are expected to result in increased amounts of affordable housing for projects participating in the MFTE program. (CRF22-10)
 - o *Schedule:* The Planning Commission is scheduled to complete their review in 2023, with anticipated PED Committee / City Council review in late 2023 or early 2024.
- 7. Signs Regulations.
 - o *Summary:* The development regulations for signs in SeaTac need to be updated to ensure that the regulations comply with a Supreme Court decision from 2015.
 - o *Schedule:* The Planning Commission is scheduled to complete their review in 2023, with anticipated PED Committee / City Council review in late 2023 or early 2024.
- 8. Land use approvals and permit process.
 - o *Summary:* The City's procedural requirements to process land use decisions and construction permits require updating to ensure consistency with recent legislation adopted by the Washington State legislature.
 - o *Schedule:* Staff are currently scoping these amendments. Planning Commission review will start in early 2024 with City Council review and action anticipated in late 2024.
- 9. Miscellaneous amendments.
 - o *Summary:* These miscellaneous amendments address a variety of topics, including recently adopted legislation by the Washington State legislature, updates for clarification of development standards, and adoption of new and / or best practices in land use regulation.
 - o *Schedule:* Staff will scope these amendments in early 2024. Planning Commission review and City Council review and action are anticipated in late 2024.

Other implementing programs or projects.

- 10. Childcare Initiative.
 - o *Summary*: Staff are working with The Imagine Institute (consultant) to continue to advertise and build awareness of this program. Since signing the contract, seven different prospective businesses and three mentor businesses have engaged with the program.
 - o *Schedule*: Staff anticipates ongoing support of this program for the life of the program. PED committee will receive an update on the program in late 2023.
- 11. South King County Housing and Homeless Partners (SKHHP).
 - o *Summary:* The City Council has budgeted money allowing the City to join SKHHP, which is a South King County consortium focused on providing affordable housing and addressing homelessness in South King County. The City will also be working with SKHHP to support an

- Affordable Housing dashboard, which will ensure consistent affordable housing reporting in South King County.
- o *Schedule:* The PED committee will be briefed on SKHHP's work in September / October 2023. Staff anticipates City Council review and approval of an Interlocal Agreement to join SKHHP and review of SKHHP's work plan in November 2023.

12. Business Synergy Annual Outreach.

- o *Summary:* In partnership with the Chamber of Commerce, staff are contact SeaTac business to improve access to resources, inform economic development programming, and verify information.
- o *Schedule:* Outreach is occurring in August through September of 2023, with a PED committee briefing scheduled for October / November.
- 13. Small Business Access to Capital Funding.
 - o *Summary:* The City will be partnering business service organizations and technical assistance providers to assist small businesses in accessing money to invest in their small business.
 - o *Schedule:* The PED committee will be briefed on the program in October / November, with contract approval occurring shortly after.

14. Digital Marketplace.

- o *Summary:* The City will be partnering with multiple organizations (Chamber of Commerce, SBDC, etc.) to improve small business digital literacy and to support the creation / expansion of online small business sales.
- o *Schedule:* The PED committee will be briefed on the project in November / December 2023, with contract approval occurring shortly after.

15. Multifamily Rental Housing Inspection Study.

- o *Summary:* The City Council funded the feasibility study of a multifamily housing rental housing inspection program. The study will evaluate the benefits and costs of such a program to inform a future decision by the City Council on whether to create the program.
- o *Schedule:* The Request for Proposals (RFP) will be released in late 2023, with the study completion anticipated in 2024. Review by the PED committee is anticipated in Q3 of 2024.

16. Permit Fee Study.

- o Summary: The City Council funded an update to SeaTac land use and construction permit fees to ensure compliance with state law.
- o *Schedule:* The Request for Qualifications (RFQ) will be released in late 2023 with the study completion anticipated in 2024. Review by the PED committee is anticipated in Q3 of 2024.

17. SeaTac Farmer's Market pilot program.

- Summary: The City Council allocated \$100,000 to partner with the African Community & Housing Development (ACHD) organization to provide a farmer's market in SeaTac. (CRF22-12)
- o *Schedule:* City staff are working on a draft contract with ACHD now; the farmer's market is scheduled to open / start in Spring 2024. A report to PED committee is anticipated in Q3 2024.
