### 2023 2nd quarter SeaTac Police Department statistics.

### Agenda Bill #6279; A Motion approving the City's 2024 Legislative Agenda.

**Summary:** The Legislative Agenda gives the Government Relations & Communications Manager and City Lobbyist, Gordon Thomas Honeywell (GTH), direction on which legislative issues to actively advocate for and which issues to react to during the legislative session.

The 2024 State Legislative Agenda consists of two documents: (1) 2024 Legislative Agenda that contains three to five top priorities for the City at the state level. GTH will proactively seek to accomplish these top priorities; and (2) 2024 Policy Document (formally referred to as the Internal Legislative Agenda). These are also called "back-page items" which give the City's lobbyist policy direction on issues that will occur during the session. GTH will react to these items when they appear during the legislative session. These documents are combined into one.

Continued discussion is scheduled at the October 10 CSS with final action scheduled for the November 14 Regular Council Meeting (RCM).

Government Relations & Communications Manager Moore introduced Gordon Thomas Honeywell Lobbyists Josh Weiss & Annika Vaughn. They reviewed the agenda bill summary and draft legislative agenda.

Council discussion ensued regarding the draft legislative agenda.
