PURPOSE

The State Environmental Policy Act (SEPA), Chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of certain proposals before making permitting decisions.

The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an Environmental Impact Statement (EIS) is required.

An EIS must be prepared for all proposals with probable significant adverse impacts on the quality of the environment.

INSTRUCTIONS

This Environmental Checklist asks you to describe some basic information about your proposal. Answer the questions briefly, with the most precise information known, or give the best description you can.

You must answer each question accurately and carefully, to the best of your knowledge. In most cases, you should be able to answer the questions from your observation or project plans, however, you may need to consult with an agency specialist or private consultant for some questions.

If You Don't Know the Answer

You may use "not applicable" or "does not apply" only when you can explain why it does not apply and not when the answer is unknown. You may also attach or incorporate by reference additional studies reports. Complete and accurate answers to these questions often avoid delays with the SEPA process as well as later in the decision-making process.

Staged Development

The Checklist questions apply to all parts of your proposal, even if you plan to do them over a period of time or on different parcels of land. Attach any additional information that will help describe your proposal, or its environmental effects. The City may ask you to explain your answers or provide additional information related to determining if there may be significant adverse impact.

'SIMPLE' LAND USE & SEPA REVIEW PROCESS

Pre Application Meeting

An applicant shall have a Pre-Application Meeting with the City before an application is accepted.

Determination of Completeness (DOC)

Upon the City's acceptance of a permit application, you will receive a "Determination of Completeness" (DOC) within 28 days of the submittal of your application stating whether your permit application is complete, not complete or if additional information is required. Note, this process only pertains to permits that require a comment period.

Notice of Application (NOA)

A "Notice of Application" (NOA) will be published and sent to adjacent property owners within 300ft -1,000 ft of the subject property. The NOA will be issued within 14 days after a DOC is issued. There is a 14 day comment period for a NOA. Note, this process only pertains to permits that require a comment period.

Notice Board Posting:

At this time, you will be required to post a "Notice Board" on the property detailing the proposed land use action. An example of the sign and further instructions will be provided to you as part of your NOA Letter.

SEPA Determination Issued

A SEPA determination will be issued shortly after the NOA comment period ends. Notification of the SEPA determination will be in the same manner as a NOA.

14 day comment period & 10 Day Appeal Period Follows

The determination will be published, posted and sent to all parties of record within 300ft-1,000ft of the subject property and to all "Parties of Record". People will have 14 days to make comment, followed by a 10 day appeal period. If no appeals are recieved, the process is complete.

Removal of Notice Board

The "Notice Board" shall be removed within 30 calendar days of the publication of the SEPA Determination.

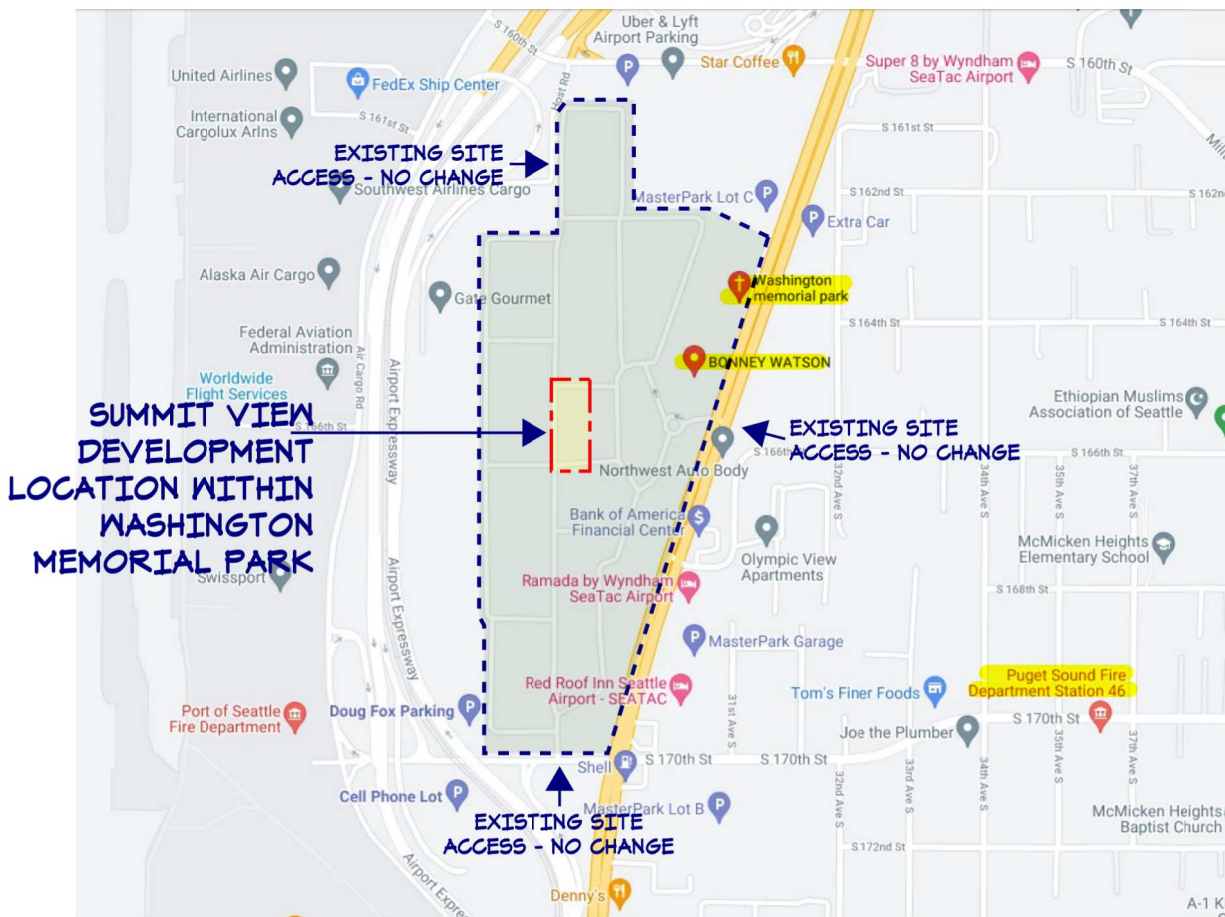

THE PAVILION WILL CONSIST OF A 2,300 SF MAIN CELEBRATION ROOM, AN ADJACENT RECEPTION FOYER, FAMILY PARLOR, CATERING KITCHEN (NO COOKING EQUIPMENT), AND SUPPORTING ACCESSORY SPACES (RESTROOMS, STORAGE). THE DEVELOPMENT SITE IS LOCATED DIRECTLY WEST OF THE EXISTING MAUSOLEUM AND TO THE SOUTH OF THE EXISTING COLUMBARIUM ALONG THE MAIN NORTH-SOUTH DRIVE CONNECTING S.160TH STREET TO THE NORTH AND S.170TH STREET TO THE SOUTH. A LARGE EXPANSE OF LAWN THAT SLOPES GENTLY TO THE EAST. IT IS BORDERED ON THE EAST BY EXISTING MAUSOLEUMS AND ON THE NORTH/WEST/SOUTH BY EXISTING DRIVEWAYS. AT THE CENTER OF THE SUMMIT VIEW DEVELOPMENT LAWN ALONG THE N/S DRIVEWAY IS AN EXISTING COLUMBARIUM BUILDING.

b. What is the steepest slope on the site (approximate percent slope)?

MAJORITY OF THE SITE IS FLAT WITH SLIGHT SLOPE FROM WEST TO EAST. THE STEEPEST SLOPE ON THE SITE IS APPROXIMATELY 19% AT THE SE CORNER OF THE DEVELOPMENT.

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them, and note any agricultural land of long-term commercial significance and whether the proposal results in removing any of these soils. FIELD EXPLORATION CONFIRMS THE SITE CONSISTS OF APPROXIMATELY THREE-INCHES OF ORGANIC TOPSOIL OVER APPROXIMATELY FOUR-TO-FIVE FEET OF FILL SOLIDS OVERLAYING APPROXIMATELY TWO-TO-FIVE FEET OF MEDIUM STIFF TO VERY STIFF SILT WITH SAND AND GRAVEL CONTENT OVER MEDIUM DENSE TO VERY DENSE SILTY SAND WITH VARYING GRAVEL CONTENT.

d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

APPROXIMATELY 1,500 CY OF ON SITE CUT AND APPROXIMATELY 2,000 CY OF FILL WILL BE USED TO PREPARE THE SITE FOR DEVELOPMENT. THE SOURCE OF FILL MATERIAL HAS NOT BEEN DETERMINED AT THIS TIME - BUT IT WILL BE FROM AN APPROVED LOCAL SOURCE.

f. Could erosion occur because of clearing, construction, or use? If so, generally describe.

UNLIKELY GIVEN THE FULL DEVELOPMENT OF THE SURROUNDING MEMORIAL PARK; HOWEVER, EROSION CONTROL MEASURES WILL BE IMPLEMENTED FOR BOTH PHASE 1 AND 2.

g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

UPON COMPLETION OF THIS PROJECT, APPROXIMATELY 48% OF THE UPPER LAWN SUMMIT VIEW DEVELOPMENT WILL BE COVERED BY IMPERVIOUS SURFACE (OPEN LAWN AREAS WILL HAVE CEMETERY PLOTS, CREMATION ALCOVES, FUNERAL MONUMENTS AND WALKING PATHS).

h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any.

EROSION CONTROL MEASURES AS REQUIRED BY THE CITY OF SEATAC WILL BE IMPLEMENTED WITH BOTH PHASE 1 AND 2.

AIR EMISSIONS WILL BE COMMENSURATE WITH SITE DEVELOPMENT AND BUILDING CONSTRUCTION. UPON COMPLETION, AIR EMISSIONS WILL BE MINIMAL FOR THE BUILDING WITH MAJORITY OF EMISSIONS CREATED BY VEHICLES FOR THOSE ATTENDING A CELEBRATION SERVICE.

YES. THE PROXIMITY OF SEATAC AIRPORT PROVIDES SIGNIFICANT AIRCRAFT AND LAND VEHICLE EMISSIONS.

HVAC SYSTEM WILL BE 100% ELECTRIC.

YES. THERE IS AN EXISTING APPROXIMATELY 5,000 SQUARE FOOT ORNAMENTAL POND LOCATED APPROXIMATELY 500-FT TO THE EAST OF THE PROJECT SITE LOCATION. THIS WATER FEATURE IS PART OF A CITY OF SEATAC DRAINAGE SYSTEM (VIA EASEMENT WITH BONNEY WATSON).

THE DRAINAGE PATTERN IN THE PROJECT AREA WILL NOT BE AFFECTED BY THE PROPOSED DEVELOPMENT.

STANDARD EROSION CONTROL MEASURES WILL BE IMPLEMENTED TO CONTROL STORM-WATER RUNOFF DURING THE CONSTRUCTION PHASE OF THE PROJECT. STORM-WATER INFILTRATION SYSTEM WILL CONSIST OF CATCH BASINS, CONVEYANCE PIPES, DESIGNED AND CONSTRUCTED IN ACCORDANCE WITH THE CITY OF SEATAC STANDARDS TO REDUCE AND CONTROL STORM-WATER RUNOFF IMPACTS.


