1. Call to Order	Chair Simpson called the meeting to order at 5:30 PM.
2. Public Comment	No public comments were given
3. Review of the Minutes	April 11, 2024 T&PW Minutes were approved
4. TIP Presentation	Informational Only Florendo Cabudol, City Engineer, gave an informational presentation on the 6-Year 2025 – 2030 Transportation Improvement Program (TIP) Update. The 6-year TIP is required by State Statute to be adopted prior to July 1 each year and submitted to the Washington State

Secretary of Transportation. It serves as a work plan to deliver City transportation projects for the next six years.

The TIP also serves to help the City budget for the next two years of projects identified in the draft TIP.

The purpose of the informational update is to allow Council and the public to give input into the identified projects in the draft TIP.

Next steps include bringing the finalized TIP back to the Committee on May 23, 2024, and then proceed to full Council for a Public Hearing and final action on June 11, 2024.

Questions from the Committee included whether we included consideration of regional and other local agencies in our draft TIP, such as King County Metro and school districts. Staff responded that we do, and can include reference to those organizations in the finalized TIP presentation. The River Ridge Elementary Sidewalk Project was an example of revising priorities and completing a sidewalk project that aligned with school district development. The committee also inquired about the criteria used to select projects and community input to the plan. The committee asked that a map of the 6-year TIP projects be made available for the public and that we work to ensure that it is easily understood by all. Committee also asked that staff ensure the TIP is translated into our top 5-languages and measures are taken to have it more understandable by the community

Status; no update at this time

6. Public Works Maintenance Division update

Bryan Chappell, Maintenance and Operations Manager presented the Maintenance Division Update.

The Maintenance Division has put an emphasis on beautification, including litter pickup and graffiti removal. In 2023, we picked up 1700 bags of litter, spent 300 hours removing illegal dumping (200 bags), and also placed an emphasis on removing litter from highway on and off ramps. Overall, the team spent over 1600 hours and removed 2500 bags of litter.

In additional they spent around 250 hours removing graffiti last year.

	Operations had a successful salmon release in April.
	Changes to the Snow and Ice program have shown positive impacts to other programs like the NPDES catch basin and cleaning requirements from DOE. Stormwater staff say the stormwater infrastructure is in great condition.
	Upcoming work will include permanent patching of potholes from over the winter and overlay program preparation.
	Thank you to Council for approving the two additional staff members; this will help us supporting our work.
7. Department Update:	Will Appleton, Public Works Director, gave the department update.
	A new grant from Department of Ecology for \$60,000 will allow the team to continue picking up litter from the freeway on and off ramps.
	We have almost finalized the Community Workforce Agreement for 34 th Avenue South Phase 2 Project.
XQ.	PW recycle event will be held on May 19 th ; for the first time on a Sunday and held along South 136 th Street between Des Moines Memorial Drive South and the SeaTac Community Center.

Subject: Final 2025-2030 Transportation Improvement Program

Purpose:

To review the Final 2025-2030 Transportation Improvement Program (TIP) and seek the Transportation & Public Works (TPW) Committee's approval to move the item forward to a public hearing at the June 11, 2024 Regular Council Meeting (RCM) and recommend Council adoption.

Background:

Each year the City prepares and adopts a Six-Year Transportation Improvement Program (TIP) in compliance with Washington State statutes. The original TIP was adopted on August 14, 1990 (Resolution 90-115). The TIP is the City's detailed transportation improvement work program that shows all future projects listed on a master spreadsheet with funding status for each project. Projects listed in the TIP include planning studies and street, bicycle, pedestrian, pavement preservation, and traffic signal improvements. In addition, projects that are funded with State and/or Federal grants are also required to be included in the TIP.

A draft TIP was presented to the TPW Committee on May 9, 2024 for review and feedback. The proposed version reflects comments and feedback from the committee, staff, and other stakeholders. This version also incorporates adjustments to project schedules to better align funding with projected construction expenditures. Projects that are programmed into the TIP that are not actively being worked on can be moved within the program as needs, funding and grant opportunities require.

Per Washington law (RCW 35.77.010), the TIP document is updated annually, with final City Council approval required before July 1 of each year. Each annual update includes a public outreach process that includes a public hearing (scheduled for June 11, 2024 RCM), prior to Council action to adopt the TIP. After adoption of the 2025-2030 TIP through a Resolution, the TIP will then be filed with the Washington State Secretary of Transportation and the Washington State Transportation Improvement Board and shared with the public.

Options/Recommendation:

Staff seeks a recommendation from the Committee to forward the Final TIP to Council at the 6/11/24 RCM to pass a Resolution adopting the 2025-2030 TIP.

WHEREAS, pursuant to RCW 35.77.010, cities are required to adopt a six-year comprehensive Transportation Improvement Program (TIP); and

WHEREAS, the Growth Management Act, at RCW 36.70A.070(6), similarly requires adoption by the City of a Comprehensive Plan transportation element that serves as a basis for the City's Six Year TIP; and

WHEREAS, the City Council conducted a public hearing pursuant to state law, to hear and receive public comment on the City's TIP; and

WHEREAS, the City Council finds that prioritized and regularly updated road and street maintenance and capital improvement projects are essential to growth management, financial planning, and assurance of a comprehensive and coordinated transportation system;


