WHY IS THIS ISSUE IMPORTANT?

1. The Planning Commission is the main community advisory group providing guidance to the Envision SeaTac 2044 project, and also has statutory responsibilities to review proposals to the Comprehensive Plan and its implementing code amendments and regulations.

TRACKING MATRIX

The matrix summarizes all draft proposed code amendments being presented. The matrix is an overall guide to the amendments being presented to help with navigation through the packet and specifically addresses:

- The amendment number
- Code section
- Name/item of section
- Type of amendment
- The purpose of the amendment (what does the amendment do?)
- The reason for making the amendment (why is the amendment needed?)



Title 15 ZONING CODE (SeaTac Municipal Code)

- Most of these changes are required for compliance with State legislation, unless noted.
- Track changes revisions addressing changes to definitions, and Section 15.120 Nonconformance and Reuse of Facilities provisions.
- For Chapter 15.120, a revision is proposed to Section 15.120.090, Alteration of Nonconforming Structure.
- Changes are also proposed to 15.465 Residential Standards and Regulations and 15.475 Temporary Uses (see below for additional explanations).



Division II. Zone Classifications and Land Use Charts

- Track changes revisions to the update abbreviations in the zone columns, to add columns for new zones, and to remove the Townhouse and Neighborhood Business zones (which are no longer needed because the Urban Medium—2,400 zones will be combined). Naming conventions are being updated to omit "density." The additional zones are created to differentiate zones within and outside of the Urban Center. These changes are consistent with your past review of the Zone and Map Designations on June 18th, as part of Code Package 1, except that the Corner Store zone is not included per discussion at the last meeting.
- Many of these changes are being proposed to align with the updated Envision 2044 Comprehensive Plan; some are proposed for compliance with State legislation.



Division IV. Citywide Development Standards, Regulations, and Incentives

- Track changes revisions to Chapter 15.465 Residential Standards and Regulations required for compliance with State legislation, as well as a City-initiated change to 15.465 Accessory Dwelling Units, removing the maximum occupancy section which results in renumbering of other sections.
- Amendment to Section 15.465.600, updating the naming convention from "Mobile Home Park" to "Manufactured Home Park" in alignment with Land Use Designations of the updated Comprehensive Plan.



Title 14 SUBDIVISIONS

- Track changes revisions addressing changes to the definitions, general standards and procedures, and short subdivision (Chapter 14.18) provisions, as required for compliance with State legislation.
- For Chapter 14.18, changes are proposed to the purpose of the chapter, as well as to add a new Section 14.18.090 for Unit Lot Subdivisions Standards.



Title 16A DEVELOPMENT REVIEW CODE

Track changes revisions to create a new Section 16A.25.050 Tribal
 Participation as required for compliance with State legislation.



Chapter 11.15 Transportation Impact Fees

 Track changes revisions addressing changes to definitions and other provisions related to imposition of impact fee on development activity, as required for compliance with State legislation.



Chapter 11.50 Transportation Concurrency Management

- Track changes revisions addressing changes to the purpose, applicability, and level of service standards as required for compliance with State legislation.
- Changes to Sections 15.50.050 Applicability and 11.50.050 Level of Service Standards are being updated to align with the updated Envision 2044 Comprehensive Plan and Land Use Designations.
