Police Captain Annette Louie Receives Recognition

SeaTac Police Captain Annette Louie was honored on May 13, by the Northwest Asian Weekly as a Women of Color Empowered award recipient. Captain Louie and 12 other professional women in law enforcement or the military were acknowledged for their success in their respective careers and as role models for all of us. Each spoke at a luncheon of supporters and community members held in the International District of Seattle. Captain Louie, who has served as a commissioned police officer for 31 years, was pleased to have a very large "rooting section" that included Councilmember Mia Gregerson and our police chief, along with other family and friends.

Crime Prevention Officer Doug Reynolds Receives Recognition

SeaTac Police Crime Prevention Officer Doug Reynolds recently received recognition for his great work in the area of Crime Prevention Through Environmental Design (CPTED). His peers in the Washington State Crime Prevention Association selected Doug for acknowledgement of his 24 hour CPTED class efforts, recognized as the "Crime Prevention Program of the Year – Law Enforcement" for the state. This was well deserved praise for Officer Reynolds, who is recognized regionally and state-wide for his in-depth knowledge of crime prevention, and his willingness to share that knowledge.

35th Session of the Citizen Police Academy Graduates

Wednesday evening saw the graduation of over 30 local citizens from the 35th session of the Citizen Police Academy. This class, co-sponsored by the cities of SeaTac, Burien, and the King County Sheriff's Office, was one of the largest in its nearly 20 year history in our city. The participants learned about police procedures and the variety of services offered by the police departments and the Sheriff's Office. They were even invited to the Criminal Justice Training Center for time at the shooting range, firing a variety of weapons used by law enforcement. They are also able to go on rides with our officers on patrol to experience first-hand that which was discussed in the class settings. The police staff had a great time with this very engaged group that included teens to members well over 60 years of age. As always, our Police Department is interested in future participants. Police Deputies Reward Kids Being “Caught” with Their Helmet On

SeaTac and Burien Deputies will be rewarding non-motorized riders for their safety efforts with a “Safe Rider Citation” card. This program is intended to increase life safety on the streets and reduce the risk of injury.

Whether riding on a bike, scooter or skateboard, or zipping along on skates, being active outdoors is a healthy choice for SeaTac children as long as they follow simple safety tips such as: wear the proper safety gear; ride safely away from cars and traffic; follow the rules of the road; ride only during full daylight. Head injury is the single most common type of injury sustained from wheeled crashes so wearing a properly fit helmet is a safety must!

Riders wearing the proper safety gear and following the rules of the road will be given a Safe Rider Citation card by Community Service Officers and Deputies. These cards are good for a free, reduced-fat vanilla ice cream cone at participating McDonald’s restaurants. One citation can be redeemed per person, per visit.

Sound Transit Fee Increase

A fare increase went into effect June 1, on Sound Transit Express Buses and Link light rail.

- King County will become one zone.
- Trips that start and end in the same county will have a one-zone fare.
- Adult trips that cross a county (zone) line will cost \$3.50.
- One-zone youth fares will be \$1.25.

Adult Link fares will rise 25 cents. Link tickets for adults will start with a base fare of \$2.00 and add five cents to the base fare for every mile of your trip.

All youth Link fares will become \$1.25, for all one-way trips on Link light rail.

All reduced Link fares for seniors/disabled will remain 75 cents, for all one-way trips on Link light rail.
