Introduction of and discussion with Douglas King, President and CEO of the Museum of Flight	X_Informational UpdateRecommended for:ApprovalApproval with modificationsDenialReferred to: City Council • Mr. King thanked the committee for its long-running support of the Museum of Flight and pledged to work closely with the SSVS and lodging industry on creative partnerships. • He gave an overview of his background and stressed that the importance of science literacy for the students in the region and for others will be one of his foremost goals. Working with other institutions and educational entities would be a key to making this happen. • An outline of the M.O.F. 's strategic planning process which will culminate with a final draft in October and indicated that the H/M Committee would be briefed and given the

opportunity to comment prior to its finalization. The 5 areas of emphasis are: The Collection Committee; Education; The Visitor's Experience; Boeing's 100 year anniversary in 2016: and a Restoration center. *He commented that he believed that the length* of stay for each visitor to the museum and the total number of visitors to the museum will be increased over the next five years. Committee members made several suggestions about increased coordination and collaboration with local and regional organizations and others. These included: increase signage at the museum crediting the public sector partners that help support the museum and its mission; closer coordination with the cruise ship sector to bring guests to the area a day earlier or incent them to stay an extra day or two. X Informational Update 4.South 200th Light Rail Link Extension Update – Soraya Recommended for: Lowry **Approval** ___Approval with modifications Denial Referred to: Lowry described the current thinking on the alignment of the extension and spoke about the locational issues for the station, park & ride and community access point. *She described the most recent iteration of the* traffic impact study and the parking plan(s) and the internal City-analysis of the current Environmental Assessment. A brief overview was provided regarding the transit-oriented development that is planned for the area in the immediate vicinity of the new station and parking structure. The current budget and financing of the extension and station development was reviewed and provided the timeline for approvals by the Sound Transit Board, which is scheduled for late July. McCracken indicated that precautions should be made to avoid a "park& fly" use of the transit's parking because it would negatively impact both private operators and the Port's parking revenues, and thus the tax generated to

	 the City. Robinson replied that this has been and will continue to be a point of discussion with Sound Transit. Lowry indicated that the Sound Transit Community Outreach staff would like to have an opportunity to speak with the H/M Committee.

10. STR Report	 The STR report was reviewed by the committee which showed a year to date increase of 7.4% in occupancy and 7.2%% increase in revenue. ADR was still lagging – but only at .2% RevPar showed strong year to year growth at a 7.2% increase.
11. Other Business	Robinson gave an update on the RFP process for the multi-sports complex and indicated that the RFPs would be distributed soon with responses due in June.
