#### **Free Summer Lunches for Children**

The Des Moines Area Food Bank will be providing free lunches and snacks for children between the ages of 1 and 18 years at Angle Lake and Valley Ridge Parks. The program begins on Tuesday, June 28, and runs through September 2, Monday through Friday. They will serve lunch at Angle Lake Park from Noon-1:00 PM and snacks from 3:00 - 3:30 PM. Lunch will be served at Valley Ridge Park from 12:15 - 12:45 PM.

The Des Moines Area Food Bank will also serve lunches at the following sites: Parkside Elementary School, Madrona Elementary School, McMicken Elementary School, Des Moines Field House, Midway Park, South Marina Park, Matt Griffin YMCA and Seahurst Elementary School.

## SeaTac Fire Assists North Highline at Major Apartment Fire

On July 24, at approximately 2:00 PM, SeaTac Engine 47 was dispatched through mutual aid with North Highline on the first alarm, to an apartment fire in the 9800 block of Des Moines Memorial Drive South. Prior to arriving, the fire was upgraded to a second alarm, and this added SeaTac units Battalion 45 and Rehab 1. First arriving units found a large four story building with multiple apartments on fire and threatening a nearby building. Within five minutes it was upgraded to a third alarm, adding SeaTac Engines 46 and 45. On arrival Battalion 45 assisted the Incident Commander and later took charge of the Operation Section. Due to the large fire and risk of collapse the fire was fought defensively.

One victim, confined to a wheelchair was rescued. Two people suffering from burns were transported to the hospital. At least twelve Engines, three Ladder Trucks and several supporting units with 64 people from nine departments were used to fight this fire. SeaTac Fire Explorers provided rehab services and their light trailer provided scene lighting into the night. The Red Cross provided on-site feeding for the displaced occupants. Metro busses were used to shelter the residents until the Red Cross could relocate them. The cause of the fire is under investigation.



# **Police Investigation**

On July 23, SeaTac Police Officers responded to a local hotel complex for an in-progress robbery in which the female victim had been robbed and assaulted. The victim had met the suspects that night and came back to their hotel room for a drink. Once they arrived, the suspects took her purse and wallet. She was able to leave the room and called the police. Police arrived and apprehended all suspects they were in possession of her stolen items either on their person or in the vehicle they had arrived in. As a normal course in an investigation, the officers ran the license plate for that suspect vehicle (a rather large SUV) and discovered it was a stolen car from the City of Des Moines.

There were numerous items in the SUV that did not belong to either the victim or the suspects so officers requested a vehicle impound to process it for evidence. King County Major Crimes detectives and fingerprint technicians processed the SUV. Some of the SUV owner's items had been pawned and detectives were able to locate the pawn shop showing a connection to the suspects. All suspects were booked in jail and criminal charges are pending.

I am writing to share how the Commercial Recycling Outreach program sponsored by the City of SeaTac has benefited Dave's Diner over the years. After a physical waste sort and seeing what was going to the land fill and what we could be recycling, was a eye opener for me. This helped us start to recycle all of our garbage at the Diner. It was estimated that up to 75% of our garbage could be recycled. After the training that was provided by the program we have now been successful with our recycling. We have a smaller dumpster that is pick up once a week instead of two times and we know that our food waste is going to composting and not down the garbage disposal, saving us on our water and sewer bill. We are now on our fourth year saving dollars every day. If it was not for the Outreach program Dave's Diner may not have been involved with this recycling program. **Agenda Bill #3347; Resolution** calling for an election on the proposition of whether the City's present Council-Manager plan of government should be abandoned and the Mayor-Council plan of government be adopted *was postponed to the August 9, 2011 Regular Council Meeting.* 

**Agenda Bill #3346; Motion** establishing the 2011 Final Docket of Comprehensive Plan Amendments was carried as amended to remove the staff alternative for Map Amendment A-1 and became effective July 26, 2011.

**Agenda Bill #3348; Motion** appointing committee members to prepare the statements for and against Ballot Proposition No. 1 for the Local Voters' Pamphlet was carried and became effective July 26, 2011.

**Agenda Bill #3349; Ordinance #11-1012** authorizing the King County Department of Elections to produce, publish and distribute a Local Voters' Pamphlet for the November 8, 2011 General Election was adopted July 26, 2011 and becomes effective and becomes effective August 6, 2011.

**Agenda Bill #3336; Ordinance #11-1013** amending Section 3.25.010 of the SeaTac Municipal Code (SMC) to amend the rate of the gambling tax imposed upon gambling activities was adopted July 26, 2011 and becomes effective and becomes effective August 6, 2011.

**Agenda Bill #3350; Motion** authorizing the City Manager to execute an Automatic First Response and Cooperative Purchasing Interlocal Agreement was carried and became effective July 26, 2011.

**Agenda Bill #3352; Motion** authorizing the City Manager to execute an amendment to the Employment Agreement between the City and Municipal Court Judge Elizabeth Cordi-Bejarano was carried and became effective July 26, 2011.
