Public Hearing and Open House on Comprehensive Plan Amendments

The City will hold an Open House from 5:00 - 6:00 PM on Tuesday, October 18 in the Council Chambers at City Hall. The purpose of the Open House is to provide information about the 2011 Comprehensive Plan amendment proposals, and answer questions that the public may have about any of those proposals.

The proposed Comprehensive Plan amendments will also be the subject of a Public Hearing at the regular meeting of the SeaTac Planning Commission that same evening, which will follow the Open House beginning at 6:00 PM. At the Public Hearing anyone may voice their support for, or opposition to, any of the proposed amendments, or may offer any other comments. Comments may also be submitted in writing via email ([mscarey@ci.seatac.wa.us](mailto:m scarey@ci.seatac.wa.us)) or regular mail. City Councilmembers and other interested parties are welcome to attend.

September 26 - October 1 - SeaTac Firefighters participated in a Multi-Casualty Incident (MCI) drill at the Kent Fire Department Training Center. The training included a review of the new King County MCI Plan, which outlines Triage, Treatment, and Transportation procedures. Our firefighters had an opportunity to practice real-world extrication



techniques on a simulated Highway with multiple cars

involved and nine critical patients. Student firefighters from Bates Technical College also helped make the drill realistic by acting as injured victims. In addition, King County Medic One, TriMed ambulance, and firefighters from Kent and Maple Valley participated in the drill.

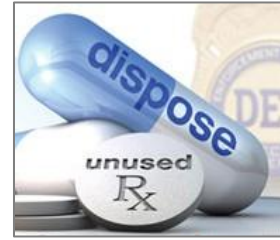


Weather Changes Means Heating Your Home

WEATHER CHANGES MEANS HEATING YOUR HOME

Protect your family and residence

City of SeaTac, Wash. October 13, 2011 –

Now that fall is officially here it is time to start considering the health and safety of your family when using furnaces or other types of indoor heating.

The SeaTac Fire Department would like to offer the following basic safety tips to help reduce the chance of a fire in your home being caused by a furnace, fireplace, woodstove, baseboard heater, or other home heating device.

- Have your furnace professionally inspected annually to ensure that it is working properly. Debris, birds, or rodents can block furnace exhausts and ducting can become clogged over time.
- Ensure that fireplaces and woodstoves are also inspected regularly. Flues/chimneys can become clogged with creosote and need to be cleaned periodically.
- Keep all combustibles *at least three feet away* from baseboard heaters, radiant heater, and any kind of free-standing wood or pellet stove. This includes bedding materials, curtains, and clothing that may have moved closer during the summer months.
- Always have a screen or glass doors in front of your fireplace to reduce the chances of any stray sparks or logs from escaping.
- Never use charcoal in a fireplace or wood stove. Charcoal emits high levels of carbon monoxide. Also, use dry, well seasoned wood when burning. Wet or green wood will not burn easily and will produce more smoke.
- Never use flammable liquids to start a fire in your fireplace.
- Always have working smoke alarms in your home. Change the batteries and vacuum them annually. Smoke alarms have a life-expectancy of approximately 10 years. If yours are older than that, or you are not sure – replace them!
- Keep a fire extinguisher handy. A 2A-10BC extinguisher is perfect for a typical home. Read the instructions on its use ahead of time.

Also, if *any* of your household appliances (including your hot water tank and clothes dryer) is fueled by natural gas or propane, consider installing a carbon monoxide alarm. Carbon monoxide (CO) is a colorless, odorless gas which is a by-product of burning. When it gets into the air in your home due

to a malfunctioning appliance, it can cause headaches, nausea, dizziness, and in extreme cases, unconsciousness and death.

Be proactive this fall and protect your home and your family. Contact your local fire department for more information.

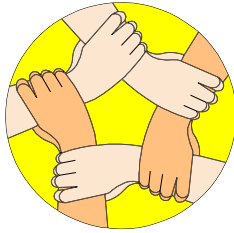
