Residential Ventilation Training

On October 7, 14, and 17, SeaTac firefighters practiced their Residential Ventilation techniques. Ventilation is a technique used by firefighters to remove smoke and heat from a structure. When performed properly, ventilation greatly assists search and rescue operations while allowing the engine companies to advance their hose lines to perform extinguishment duties. At a structure fire, firefighters may need to cut holes in the roof to draw heat, smoke, and fire up and out of the building. This technique increases survival time for victims by channeling heat and smoke away from them. The training was conducted at the Kent Fire Training Center on their residential roof prop.



Police News

The Crimes Against Children Unit of FBI Headquarters has been in discussions with the Department of Health and Human Services (DHHS) regarding adopting a cooperative approach in working with victim service providers, particularly residential programs. Together, they have identified four programs around the U.S. that will serve as pilot projects where DHHS will fund existing programs in order to provide more services for victims of Domestic Minor Sex Trafficking. The four programs are in Miami, Toledo, Everett and Seattle (Youthcare).

On October 19, the Crimes Against Children Unit and DHHS will host an initial coordination meeting in Washington D.C. including the corresponding FBI Victim Specialists and Innocence Lost Task Force (ILTF) Coordinating Agent and the service providers.

Detective Brian Taylor from the SeaTac Police Department has been selected to attend this meeting, to represent the law enforcement perspective of the Seattle ILTF in the coordination discussions involving all parties. This meeting is being held in Washington, DC and the FBI is paying for his transportation and lodging while he is participating in this event. The SeaTac Police Department has been involved with the regional task force the last couple of years focusing on juvenile victimization.
