SeaTac Fire Responds to Significant Accident on I-5

On October 18 at approximately 10:15 AM, SeaTac Engine 45 and Battalion 45 along with Port of Seattle Engine 712, responded to a reported motor vehicle accident on southbound I-5 near S. 188th Street. On arrival, Engine 45 found multi-car accident involving ten cars, two with serious damage. The vehicles were spread out along the freeway and blocking all but two lanes. Engine 45 triaged and identified seven patients in four vehicles. Engine 45 established I-5 Command and requested a medic unit. Two Tukwila Fire units responding to a report of a different accident were added to the alarm, when it became apparent that they were the same accident. A total of seven patients were treated at the scene and six were transported to local hospitals by ambulance with non-life-threatening injuries.
