# Dear Mayor, Councilmembers, Residents, and Employees:

## **City Hall Closure**

City departments will be closed from 10:30 AM to 1:30 PM on Monday, December 12, 2011, for an Annual Citywide Staff Meeting and Employee Awards Ceremony being held at the SeaTac Community Center. Police personnel and firefighters are the exception. These vital public safety services will not be affected. Additionally, the City will staff the reception desk at both City Hall and the Community Center to assist callers and visitors during the closure.

# **Caring Community Cookie Project**

# **Citizen Advisory Committee Vacancy**

The City of SeaTac has an immediate vacancy for a Planning Commissioner.

The Planning Commission is to study and make recommendations to the City Council for adoption of long range comprehensive plans, policies, programs and services related to land use, transportation and community facilities. The Commission also studies and makes recommendations to the Council on a variety of development regulations. The Commission's goal is to maintain and achieve the highest level of the City's attributes so that all SeaTac citizens can enjoy and be proud to live in this community. Planning Commissioners are appointed by the Mayor and Council; the Commission consists of five members, each serving three year terms. Meetings are held on the first and third Tuesday of each month at SeaTac City Hall.

# **Police Training**

November 28 - 30, the SeaTac Police Department hosted a DUI Detection and Standardized Field Sobriety Testing (SFST's) training for commissioned police officer's. The class was taught by SeaTac Sergeant Ted Boe, SeaTac Master Police Officer Eric Lewis and Deputy Cory Stanton (Maple Valley Police). The class had 18 students (officers) from the King County Sheriff's Office, the Kent Police Department, the Snohomish County Sheriff's Office, the Eatonville Police Department, the Gig Harbor Police Department and the Seattle Police Department.



The Washington State Traffic Safety Commission requires all officers participating in traffic enforcement grant funded programs (i.e. Click It Or Ticket, Target Zero DUI emphasis and speed enforcement emphasis) to have up to date training in the area of DUI Detection and SFST's. This class also provides an introduction to drug impaired driving. The

SeaTac Police Department has been actively providing this training, along with other police agencies, for the last two years.

## No one home during SeaTac house fire

At approximately 9:30 PM Monday night, SeaTac Fire Department Engine 46 was dispatched to a report of smoke coming from a building in the 3200 block of S. 164th Street. When the SeaTac Fire Engine arrived they reported thick, dark smoke from the eaves of the building and upgraded the call to a full residential fire and requested additional help from SeaTac Fire Engine 45, 47, Battalion 45, Port of Seattle, Tukwila and North Highline Fire Departments. The first arriving crew forced entry into the building and found a fire in the basement which had extended up into the first floor. The fire was quickly extinguished and firefighters searched the building for any hidden fire. No other fire was found. The cause of the fire is under investigation and no damage estimates are available at this time. No one was at the home at the time of the fire and no injuries were reported to any firefighters.
