#### **Holiday Closure**

City Hall and City facilities will be closed on Monday, January 16 in observance of the Martin Luther King, Jr. holiday.

## January 10, 2012 Regular Council Meeting

At the Regular Council Meeting on January 10, 2012, Council passed a resolution amending the City Council Administrative Procedures and repealing Resolution 11-006 related to Council Committee meeting times. Specifically, the standing committees of Administration and Finance, Public Safety and Justice, Land Use and Parks and Transportation and Public Works have been eliminated. Instead the Council will hold Study Sessions in order to address City business in advance of the Regular Council meetings. The Study Sessions will occur on the second and fourth Tuesday of every month commencing at 4:00 PM in Council Chambers, followed by Regular Council Meetings commencing at 6:00 PM.



Outgoing Councilmembers Gene Fisher and Ralph Shape received their Keys to the City in appreciation of their dedicated service on the City Council.

Re-elected Councilmembers Terry Anderson and Mia Gregerson, along with newly elected Councilmembers Barry Ladenburg and Dave Bush, signed their oaths of office and

were sworn-in by Judge Elizabeth Bejarano.

The Council elected Tony Anderson as Mayor and Mia Gregerson as Deputy Mayor.
