b) REVIEW FINAL DRAFT OF FIRE CAPTAIN PROMOTIONAL EXAM ANNOUNCEMENT

- i. Ms. Johnson reported she may have to postpone the announcement to Friday, January 13, 2012, as all required books are not yet available. She will ensure all test materials will be available by that date.
- ii. Commissioner Thomas suggested that when testing is completed, all study materials and books be returned by a specific date.
- iii. Ms. Johnson reviewed final draft, as follows:
 - April 23, 2012 Required Orientation

- May 7, 2012 Written Test (weighted 100%) passing score 70%
- May 4-18, 2012 Tactical Test (weighted 25%), Assessment Center Test (weighted 30%) & Behavioral Based Test (weighted 45%) – combined passing score of 70%
- May 23, 2012 Test Review/Protest Process
- May 23-25, 2012 Protest Period

After some discussion on format, it was decided to divide the one paragraph in the TEST SCORE section into several smaller paragraphs for better readability.

<u>Motion:</u> Commissioner Sitterley made a motion to approve the final draft with the above changes. Commissioner Thomas seconded the motion. Motion passed.
