Sea-Tac Airport's Rental Car Facility to Open May 17



To support the installation of roadway signage for the opening of the new Rental Car Facility, starting Monday night, May 14, and through early Thursday morning, May 17, there will be night-time lane closures on westbound State Route 518, International Blvd, Air Cargo Rd, S. 170th St., S. 160th St., and the Airport roadway system.

Monday, May 14 to Tuesday, May 15

- Between 8:00 PM and 4:00 AM, construction crews will have lane closures on S 170th St and Air Cargo Rd.
- Between 11:30 PM and 4:30 AM, construction crews will have two lane closures on the southbound lanes of the Airport Expressway.

Tuesday, May 15 to Wednesday, May 16

- Between 8:00 PM and 11:00 PM, construction crews will have lane closures on eastbound State Route 518 in the vicinity of the Airport exit.
- Between 11:30 PM and 4:30 AM, construction crews will have lane closures on westbound State Route 518 in the vicinity of the Airport exit, and on the Airport exit from westbound State Route 518. Construction crews will also have two lanes closed on the northbound lanes of the Airport Expressway between S 182nd St and S 160th St.

Wednesday, May 16 and Thursday, May 17

- Between 8:00 PM and 4:00 AM, construction crews will have the north parking entrance and rental car return to the Airport garage closed. A detour for parking customers will be in place through the Departures curbside to the south parking entrance. A detour for

rental car return will be in place through the approach to the Arrivals curbside until 4:00 AM when all rental car returns will be relocated to the new Rental Car Facility.

- Between 11:30 PM and 4:30 AM, construction crews will have two lane closures on the southbound lanes of the Airport Expressway.
- Between 11:30 PM and 4:30 AM, construction crews will also have intermittent lane closures on westbound State Route 518, International Blvd, Air Cargo Rd, S 170th St, and S 160th St in the Airport vicinity.

Zone 3 Mass Casualty Incident Drill (MCI)

Beginning the week of April 9th, through May 3rd, SeaTac Firefighters participated in several Mass Casualty Incident (MCI) drills at the ShoWare Event Center in Kent. The training included a review of the new King County MCI Plan, which outlines Triage, Treatment, and Transportation procedures. SeaTac firefighters had an opportunity to practice real-world MCI procedures with neighboring fire departments for a simulated mass shooting involving more than ten critical patients. Volunteers made the drill more realistic by acting as injured victims. King County Medic One, TriMed ambulance, and American Medical Response also participated in the drill.



Citizen Advisory Committee Vacancies

The City of SeaTac has immediate vacancies on the Hotel/Motel Tax Advisory Committee and Senior Citizen Advisory Committee. The deadline for applying is June 1, 2012.

The Hotel/Motel Tax Advisory Committee assists the City Council in Hotel/Motel Tax related decisions. The Hotel/Motel Tax Advisory Committee consists of nine members each serving three year terms. Meetings are held at SeaTac City Hall on the second Wednesday of each month for Hotel/Motel and the third Tuesday of each month for the Senior Citizen Advisory Committee at SeaTac City Hall. The Senior Citizen Advisory Committee consists of five members each serving three year terms. Committee members are appointed by the Mayor and City Council. The Senior Citizen Advisory Committee's Mission is to work with the Staff Liaison to identify issues related to senior citizens in the community; act as an advisory body to the City Council and provide input through the City Manager and the Staff Liaison to the City Council on issues relating to SeaTac senior citizens; provide increased opportunities for community involvement by SeaTac

senior citizens and the community in general; advise the City Council, through the city manager and the staff liaison regarding the delivery of senior citizen programs and provide outreach to the community in an effort to develop and place senior citizen issues before the citizens of the City of SeaTac in a positive manner.
