Dear Mayor, Councilmembers, Residents, and Employees:

Spring Yard Debris Collection Event April 25: Turn your yard debris into a valuable resource instead of having it end up at the landfill. Bring yard debris to SeaTac's Spring Yard Debris Collection Event this Saturday, April 25, from 9:00 AM to 3:00 PM at Tyee Educational Complex's parking lot. SeaTac staff and Allied Waste will collect grass, leaves, and branches to transport to Cedar Grove Compost, saving about 100 tons of material per event from the landfill. This event is free to SeaTac residents and is co-sponsored by the City of SeaTac.

SeaTac Domestic Violence Task Force Food Drive for Highline Area Food Banks: This Saturday, April 25, from 9:00 AM to 3:00 PM in conjunction with the spring yard debris event, please bring canned and non-perishable food, diapers, toilet paper, soap, pet food, and laundry detergent to donate to SeaTac's Domestic Violence Prevention Program. Paper bags and cash donations are welcome too!

Rain Barrel Sale: SeaTac residents can purchase a rain barrel in front of SeaTac City Hall this Saturday, April 25, from 9:00 AM until noon, at a subsidized price of \$20 each (cash only). Limit of three per household.

Rain barrels are low-cost water conservation devices that can help to reduce the volume of runoff. Rainwater collection offers many advantages including savings on your water bills, better quality of water (oxygenated and not chlorinated), ensures water for your garden, and there's no withdrawal from groundwater.
