Burien/SeaTac Wastemobile Event

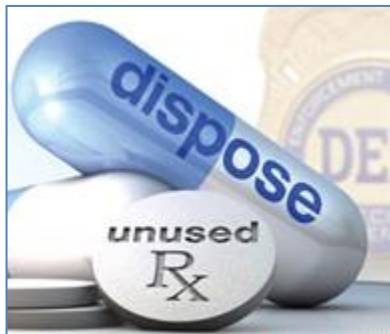
The King County Regular Wastemobile travels to many communities to provide household hazardous waste disposal services for King County residents. This free mobile service operates at the different locations in King County from March to October. Bring your household hazardous waste to the Wastemobile collection event in Burien for the weekend listed below.

Dates: Friday, September 14 – Sunday, September 16
Hours: 10:00 AM – 5:00 PM
Location: Burien Fred Meyer, 14300 1st Avenue S.

Restrictions: No latex paint accepted. There is a limit of 50 gallons total hazardous waste per **residential** customer per day at all Wastemobile events. No more than 30 gallons of gasoline will be accepted from residents. No containers over five gallons in size will be accepted. Limit of 10 fluorescent tubes/bulbs (not accepted from businesses), and limit of five automotive batteries.

Safe handling: Do not mix products. Keep products in their original containers; label products that are not in their original containers. Secure products so they do not tip over and/or leak; transport similar, sealed containers upright, in cardboard boxes. Secure the load in the vehicle or trailer, and store products away from the passenger compartment.

The Wastemobile accepts a wide variety of materials and is free of charge. DEA National Pharmaceutical Take-Back Day at SeaTac City Hall

Saturday, September 29

The Federal Drug Enforcement Administration and participating local law enforcement are coordinating a nationwide drug “take back” day on September 29, from 10:00 AM to 2:00 PM. This one-day event will provide residents with no cost anonymous collection of unwanted or expired medicines.

Why Take Back Your Meds?

All medicines that your family and pets use should be properly disposed of at a drug take-back program. Medicine take-back programs are the only secure and environmentally sound way to dispose of leftover and expired medicines.

Reduce access to medicines for misuse

Prescription drug abuse is the fastest-growing drug problem in the country. In Washington State 11% of teens use prescription medicines for non-medical reasons, a rate among the highest in the nation. Over half of teens abusing medicines get them from a family member or friend, often without their knowledge.

Reduce potential for accidental poisonings

Unwanted medicines left in the home endanger our children, seniors and pets. Over half of the 37,000 calls to the Washington Poison Center in 2009 were for young children poisoned by medicines found at home. The elderly are also at risk of accidental poisonings and human medications are the leading cause of pet poisoning.

Reduce medicines in the environment. Don't flush! Don't trash!

Flushing drugs send them into our waters. Throwing them in the garbage makes them available for others to take and use and can still get into the environment. Take-back programs are the only secure, environmentally sound way to dispose of unwanted medicines.

Police Investigation – Credit Card Scams

The SeaTac Police Department is working in conjunction with the Kirkland Police Department focusing on an on-going investigation pertaining to credit card scams involving elderly victims. Suspects are targeting people at grocery stores while they checkout to get the person's PIN number. They follow the unsuspecting victim to their car and pull a ruse that they need assistance in find a location on a map or to ask for directions. While the victim is distracted they unlock the car get inside to take their wallet for their credit card. The credit card is skimmed to copy the information on the back strip and the card is returned. They are using that information to access the victim's accounts.

When using your debit card, make sure that you cover the key pad as you enter your PIN number. Do not engage in conversation with strangers asking for directions when they approach your car. Call the police if you suspect this activity is occurring.

Citizen Advisory Committee Vacancies

The City of SeaTac has immediate vacancies on the Planning Commission and Senior Citizen Advisory Committee.

The Planning Commission is to study and make recommendations to the City Council for adoption of long range comprehensive plans, policies, programs and services related to land use, transportation and community facilities. The Commission also studies and makes recommendations to the Council on a variety of development regulations. The Commission's goal is to maintain and achieve the highest level of the City's attributes



so that all SeaTac citizens can enjoy and be proud to live in this community. Planning Commissioners are appointed by the Mayor and Council; the Commission consists of five members, each serving three year terms. Meetings are held on the first and third Tuesday of each month at SeaTac City Hall.

The Senior Citizen Advisory Committee consists of five members, each serving three-year terms. Committee members are appointed by the Mayor and City Council. The Senior Citizen Advisory Committee's Mission is to work with the Staff Liaison to identify issues related to senior citizens in the community; act as an advisory body to the City Council and provide input through the City Manager and the Staff Liaison to the City Council on issues relating to SeaTac senior citizens; provide increased opportunities for community involvement by SeaTac senior citizens and the community in general; advise the City Council, through the City Manager and the Staff Liaison regarding the delivery of senior citizen programs and provide outreach to the community in an effort to develop and place senior citizen issues before the citizens of the City of SeaTac in a positive manner. Meetings are held on the third Tuesday of each month at SeaTac Community Center.

The application for the Planning Commission and Senior Citizen Advisory Committee can be found on the City's website at www.ci.seatac.wa.us under the Government heading select City Departments, then select City Clerk, and on the City Clerk page select Citizen Advisory Committees.

The deadline for applying is Monday, September 24, 2012. If you are interested in serving on this Committee, please contact the City Clerk's Office at 973.4660.

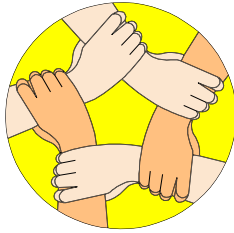
