Free flu vaccination clinics

People without health insurance can get best protection against flu

Along with the rest of the nation, King County is experiencing widespread flu, with more people sick and requiring medical care early in the flu season compared to recent years. Public Health – Seattle & King County is offering free flu vaccination clinics to make flu vaccine more widely available to people without health insurance or who are unable to pay. Flu vaccine (shots and nasal spray) is also available at many healthcare provider offices and pharmacies for those who have insurance or are able to pay for vaccination. About the Free Flu Vaccination Clinics

- No other vaccinations will be offered at the time of the clinics.
- You will be able to get flu shots or nasal spray vaccines, and preservative-free, gelatin-free, and latex-free vaccines will be available.
- You do **not** need to be a regular client at Public Health Centers and you do **not** need to show proof of citizenship to get the vaccination.

Firefighter Survival Training & Emergency SCBA Operations

January 7 - 9, SeaTac and other local firefighters received training in Firefighter Survival and Emergency SCBA Operations (Self-Contained Breathing Apparatus). The training involved three skill stations: (1) Firefighter rescue through a basement floor collapse, (2) Firefighter rescue through an exterior wall, and (3) SCBA Confidence Course/Mayday Procedures/Emergency SCBA Operations. The training was delivered by the South King County Fire Training Consortium, with SeaTac, Kent, Maple Valley, Tukwila, and Burien/North Highline participating.



NAPCA National Multilingual Toll-Free Helpline

NAPCA (National Asian Pacific Center on Aging) provides the only national toll-free Asian language Helpline, an innovative, award-winning service for limited and non-English speaking elders, created to assist those seniors speaking Chinese, Korean and Vietnamese. The NAPCA Helpline assists those seniors seeking information and assistance to avoid English-only operators and automated phone menus by having separate phone lines dedicated to each language. Callers receive counseling directly in their desired language by bilingual and bicultural subject matter experts. Limited and non-English speaking seniors occasionally receive translated information from government agencies and national community organizations, but need assistance with additional questions or help enrolling or applying for benefits or programs. Highly qualified multilingual staff handles callers' inquiries.

- Overseeing the Port of Seattle, which includes the Northwest's biggest seaport, Seattle-Tacoma International Airport, Fisherman's Terminal, cruise ship terminals, and a real estate portfolio.
- Working with the State, King County and King County's 39 cities.
- Serving on outside boards and committees.
- Attending and speaking at community functions, events, and receptions.

Compensation

Current commissioner compensation is \$500 per month, plus per diem. Commissioners are also eligible to participate in the port's medical program.
