2005 Interlocal Agreement

- Parking tax revenue projection
- Developed capital improvement list and allocations through joint transportation study

Projects	Percentage	Total
South Access	22%	
Westside Trail, Ring Road	<u>14.9%</u>	36.9% Port Projects
City Projects	<u>63.1%</u>	63.1% City Projects

2007 Amendment

- \$5 million for SR 518 out of South Access set-aside
- Changed "Ring Road" to "North SeaTac Roadways" in list of eligible Port projects



Parking Tax Revenue





New Amendment

- Adds 170th Street Roundabout for up to \$1 million (Port is lead)
- Adds 28th/24th Avenue South for up to \$4 million (City is lead)
- South Access won't be built during current agreement
- Does not alter Port's obligation to build South Access



- Temporary traffic light installation
- Cell phone lot relocation complete April 2014
- Roundabout construction complete fall 2014
- Port lead agency on project

South Access Traffic Study

- \$200,000 from South Access set-aside
- Study phased approach for South Access (SR 509 Option C)
- Share transportation model = align analysis
- Support City's update of Transportation Element of Comprehensive Plan
- Support Port's update of Transportation Element in Sustainable Airport Master Plan

SR 518	(\$5 M)
28th/24th Avenue South	(\$4 M)
South 170th Roundabout	(\$1 M)
Transportation Study	<u>(\$.2M)</u>
