City of SeaTac Civil Service Commission Minutes of Meeting held on Monday, July 8, 2013

1. Call to Order

The regularly scheduled meeting of the SeaTac Civil Service Commission for Fire Department Employees was called to order at 3:30 p.m. on Monday, July 8, 2013. The meeting was held at SeaTac City Hall in conference room 128, located at 4800 South 188th Street, SeaTac, WA 98188.

3. Regular Business

a) APPROVAL OF MINUTES

<u>Motion</u>: Commissioner Thomas made a motion to approve the Minutes of the Civil Service Commission's May 13, 2013 meeting. Commissioner Drebert seconded the motion. Motion passed.

b) Update on Fire Department Consolidation

A/C Wiwel updated the commission on the consolidation with Kent Regional Fire Authority. There was a joint meeting with RFA and SeaTac City Council, and a first review of the contract between both agencies.

The unions voted on the proposed contract. Kent's union local must pass at 50% + 1 and SeaTac's union local must pass at a 2/3 majority. SeaTac vote passed 38 to 6. About the same (85%) approval from both bargaining units occurred.

As the SeaTac City Council reviews the contract, they will address questions like the transfer of assets, unfunded liabilities, etc. The second council meeting in July will be the study session to look at these items, with a potential vote on the contract at the August 13th council meeting.

c) Commission Photo

Commission Drebert asked about the Commission Photo taken previously. Ms. Johnson reported the photo was provided to the Annual Volunteer Luncheon committee staff.

4. Next Meeting

The next regularly scheduled meeting will be held on Monday, August 13, 2013 at 3:30 p.m. at SeaTac City Hall, Conference Room 128. The regularly scheduled meetings may be adjusted by the Chief Examiner in correlation with Council business on the RFA vote for efficiency.
