

## **Cedarbrook Lodge Expansion Permits**

CED issued the master site development permit for the \$15.5 million expansion of the Cedarbrook Lodge this week. The master building permit is set to be issued by early next week. The expansion adds 63 rooms and suites, and a spa to the 104 unit facility, and will include other improvements to the existing meeting and event spaces. Deputy Mayor Mia Gregerson presented comments on behalf of the City at the project's official groundbreaking on Thursday, December 12. Council members Rick Forshler, Terry Anderson, Dave Bush and Pam Fernald were also in attendance along with a few City staff members.

Construction is scheduled to begin immediately and is expected to be completed by fall 2014. Throughout the construction, vehicles and materials will be staged on the property at the corner of S. 188th Street and 36th Avenue S. This site was similarly used for construction of the YMCA and for this year's S. 188th Street re-paving project.

#### **Committee Vacancies**


The City has immediate vacancies on the Human Services Advisory Committee, Library Advisory Committee and the Tree Board. These committees serve in an advisory capacity to the City Council with five members each, serving three year terms.

The Human Services Advisory Committee is looking for candidates to fill one expiring term. This committee makes reports and recommendations to the City Council concerning human services issues. Meetings are held on the third Monday of each month at SeaTac City Hall beginning at 5:30 PM.

The Library Advisory Committee is looking for candidates to fill one expired term. This committee coordinates with, and provides input to, the Board of Trustees of the King County Library District and local library official. Meetings are held quarterly on the second Wednesday of the month, or as needed, at Valley View Library or SeaTac City Hall at 5:00 PM.

The Tree Board is looking for candidates to fill one expired term. The Tree Board makes reports and recommendations to the City Council concerning a comprehensive Public Tree Care Plan for the Parks and Public Works departments, Public Tree Hazard Assessment and Inventory, and implementing an Arbor Day Observation/Celebration and Proclamation. Meetings are held on an asneeded basis at SeaTac City Hall.

# Fire News SeaTac Fire Assists North Highline at a House Fire

On December 5, at approximately 9:15 PM, SeaTac Fire Engine 47 responded to a residential fire in the 12600 block of 16th Avenue S., North Highline. North Highline E19 was first on location and found that a chimney fire had extended into the attic and wall. When Engine 47 arrived they were assigned the attic fire and forced entry through the gable and extinguished the attic fire. North Highline units extinguished the fire in the living room wall.

#### SeaTac Fire Assists Renton at a House Fire

On December 7, at approximately 11:15 AM, SeaTac Fire Rescue 46 was dispatched to assist Renton Fire Department on a large house fire in the 1300 block of Redmond Place NE. Rescue 46 provided air refills utilizing its breathing air compressor and cascade system for the self contained breathing apparatus in use at the fire.

#### **SeaTac Fire Quickly Extinguishes Apartment Fire**

On December 7, at approximately 8:15 PM, SeaTac Fire Engine 45 was dispatched to a possible fire in an apartment in the 3000 block of S. 204th Street. The response was upgraded, bringing Firefighters from SeaTac, the Port of Seattle, South King Fire and Rescue. When they arrived on scene they found a living room fire in an upstairs apartment of a two story building.

The fire was extinguished before it could spread to other apartments. There was some smoke damage to the hallway outside the apartment and in the adjacent second story apartment.

Both of the residents were able to get out safely and no other residents were affected. There is no indication that there were working smoke alarms. Two cats died in the fire due to smoke or carbon monoxide poisoning. While the cause of the fire is still under investigation, it appears to be accidental.

From December 7 through December 10, SeaTac Fire units were kept busy responding to multiple calls for pipes that had frozen and then burst as they thawed.
