CM Fernald encouraged residents to apply for the openings on citizen committees: (1) Library Advisory Committee; (2) Tree Board; and (3) Senior Citizen Advisory Committee.

CM Bush commented on the following: (1) threw the first baseball for the little league; (2) volunteered for the bicycle rodeo, and (3) attended the Somali conference with DM Gregerson.

DM Gregerson stated that SeaTac had two schools that were Washington State finalists in soccer, Seattle Christian and Tyee Totems.

Mayor A. Anderson and DM Gregerson thanked Council for passing the Resolution on the Transportation Investment Package.
