


SeaTac Municipal Court State of the Court 2014-2015

Our Mission:

- To serve the public by providing a safe forum, accessible to all individuals, for the fair, impartial, and efficient administration of justice.
- To conduct outreach in an effort to provide the SeaTac community information on issues related to constitutional rights, the judicial branch, and the law.

Case Filings:



Case filing increase

- In 2013, all but one case type increased:
 - Traffic Infractions 1 7%
 - Non-Traffic Infractions 136%
 - Parking and Photo Enforcement 125%
 - DUI's 17%
 - Criminal Traffic
 \$\mathbf{1}\$ 3%
 - Criminal Non-Traffic
 \$\bullet\$5%

Overall increase: 118%

Warrant Walk-ins = Jail savings

- ▶ 167 Defendants in 2013 avoided arrest through Warrant Walk-in Program
- Savings of at least 334 jail days (day of booking, ordered for video next day)

nCourt Online and Phone Payment Option:

- Received \$135,066.68 in payments through nCourt in 2013
- Increase in receipts from nCourt of 59% over 2012

Intership Program

- Previously had interns from Highline Community College Paralegal program
- In late 2013, through Law Week, the Court had the benefit of an intern from Central Washington University's Highline Community College campus.
- Intern worked on planning Law Week event, engaging the community, and made a presentation to City Council

Improvements 2013–2014

- AllianceOne Collections:
 - "Red line" Phone in Court lobby that provides a direct connection for customers to make payment arrangements
 - Automated receipting of collections/payments using newly created software for courts by "CodeSmart"
 - Connects case information from state system with AllianceOne collection information automatically
 - Saves court staff time entering and processing payments
- Technology / Facility improvements:
 - Jail video run through projector equipment
 - Cameras capture Prosecutor, Judge, and Inmate (with Defense Counsel)
 - Cameras capture Court room, Court lobby
 - Shelf in Court room for defendants to sign paperwork

Interpreter costs:

- State Reimbursement for interpreter costs:
 - \$7,684.45
- ▶ Total Above Projected Revenue: \$2,684.45
 - Total Expenditure for Interpreter services Below Budget: \$11,007.88

Probation Services

- On average, 156 cases on "Active" Probation
 - 44% DUI/Physical Control
 - 22% Domestic Violence
 - 15% Reckless Driving/Negligent Driving 1st
 - 13% Other
 - 6% Theft

Probation services (continued):

- Jail Alternatives (funded by Defendants)
 - Defendants served 43 days through Day Reporting
 - Served in lieu of 57 days jail
 - Defendants served 346.5 hours through Community Service
 - Community benefited from work hours
 - Served in lieu of 99 days jail
 - Defendants served 242 days through Electronic Home Monitoring
 - Served in lieu of 242 days jail
- Total jail days saved in 2013 using alternative sentencing: 398 days

Law Week 2013

- Recognized by American Bar Association as a finalist for their 2013 Outstanding Activity Award

 - Presenters included Mayor Gregerson, Des Moines Mayor Dave Kaplan, Judges from Des Moines and Bremerton, Representatives from Senator Patty Murray's office and Senator Adam Smith's office, King County Prosecutor Dan Satterberg, Former Seattle Mayor Norm Rice, John Keister

Leading the Way

- Increased profile in Court Community through our outreach programs

What we are working on...

- "Form Management" with CodeSmart/City of Renton/City of Tukwila
 - Newly created CodeSmart software provides form management
 - Increases efficiencies in Court room and for SCORE hearings
 - Software auto-populates forms using information from calendars and state information system
 - Enables significant reduction in paper use
 - Cooperative effort with the City of Renton and City of Tukwila Municipal Courts for cost sharing
